RESPONSE IN PARTIAL OPPOSITION TO MOTION TO CONSOLIDATE CASES

Plaintiffs, The Andrew Goodman Foundation and Amanda Scott, file this Response in Partial Opposition to the State's Motion to Consolidate Cases, ECF No. 29.

Plaintiffs do not oppose consolidation with *Common Cause, et al. v. Thomsen, et al.*, No. 19-cv-323 (W.D. Wis., Judge Peterson).

Plaintiffs do, however, oppose consolidation with *One Wisconsin Inst., Inc. v. Jacobs*, No. 15-cv-324 (W.D. Wis., Judge Peterson) and *Luft v. Evers*, No. 11-cv-1128 (E.D. Wis., Judge Peterson) for any purposes, including for any proceedings contemplated ahead of the November 3, 2020 election. The above-captioned matter lodges a Twenty-Sixth Amendment challenge to Wisconsin's Student Voter ID Restrictions, as set out in Wis. Stat. § 5.02(6m)(f). Neither the Twenty-Sixth Amendment nor the Student Voter ID Restrictions are at issue in either the *One Wisconsin* or *Luft* cases. Rather, these cases were remanded by the Seventh Circuit specifically to address issues involving Wisconsin's Identification Card Petition Process (IDPP) for "free" voter

identification. The IDPP is not implicated by either Plaintiffs' claim or the facts in this case. Accordingly, consolidation for any purpose is inappropriate.
