**PLAINTIFF BLACK VOTERS MATTER FUND'S
RESPONSE TO COURT'S INQUIRY**

Pursuant to this Court's request during the April 24, 2020 hearing for a statement from Plaintiff Black Voters Matter Fund concerning its role in stamp distribution, see Doc. 75 at 113:24-115:5, Plaintiffs attach a Supplemental Declaration of Cliff Albright, labeled as Exhibit O.

Paragraphs 37-39, as well as 14-17, 25-26 and 43-44, appear to most directly address this Court's question about the specific role that Plaintiff plays in stamp distribution. However, out of an abundance of caution, Plaintiff Black Voters

Matter Fund believes it should include other facts that place direct stamp distribution is placed in proper context in terms of how Plaintiffs have diverted, and would divert, their resources this year on other initiatives in response to the postage requirement. These other initiatives include adding layers of voter education that informs voters about how to obtain postage themselves, which is just as important as direct stamp distribution.
