RULE 7.2(n) NOTICE

1 Under Local Rule 7.2(n), when a matter has been under advisement “for more than
2 one hundred and eighty (180) days, the attorneys of record in the case shall inquire of the
3 Court, in writing, as to the status of the matter.” LRCiv. 7.2(n). Pursuant to that rule,
4 Plaintiffs respectfully notify the Court that over 180 days have passed since the Court took
5 the merits of the case under advisement at the close of trial. Plaintiffs note that, while the
6 Court stated during the April 9 status call that a decision was in progress, the Court did
7 not specify when the parties should expect a ruling.

8 Plaintiffs further note that an expeditious decision is particularly important in this
9 case given that it may affect the administration of upcoming elections. Arizona will hold a
10 partisan primary on August 28, 2018, and the general election will be held on November
11 6, 2018. *See* Office of the Secretary of State, [https://www.azsos.gov/elections/elections-](https://www.azsos.gov/elections/elections-calendar-upcoming-events)
12 [calendar-upcoming-events](https://www.azsos.gov/elections/elections-calendar-upcoming-events). Moreover, there is a high likelihood that, irrespective of the
13 Court’s decision on the merits, one or more of the parties will seek review of this Court’s
14 decision, meaning that final resolution of this case will likely take some period of time
15 after this Court issues its ruling.

16 Plaintiffs have informed the State Defendants and Intervenor-Defendants that they
17 would be submitting this notice. The State Defendants declined to join on the basis of
18 their conclusion that this notice is not necessary due to the Court’s oral status update on
19 April 9.
