**PLAINTIFFS' MOTION FOR CLARIFICATION ON VIDEO
ATTENDANCE AT TRIAL**

Plaintiffs have received this Court's Sealed Notice, ECF 374, and respectfully seek clarification on two points.

First, Plaintiffs seek clarification as to whether the agents of attorneys of record—including paralegals and litigation support specialists—may attend and view the video trial in order to assist attorneys of record, including with document presentation and technology support. Such agents would not appear on video.

Second, Plaintiffs seek clarification as to whether parties, including Individual Plaintiffs and at least one representative of each Organizational Plaintiff, may attend the trial by video. Such parties would not appear on video unless they have been designated to testify, and only during the time of their testimony. If attendance by

parties affects the functioning of the videoconference platform, we would adjust the parties' attendance as necessary.
