NOTICE OF APPEAL BY PLAINTIFFS JILL REARDON AND JUDITH BRACHMAN

Plaintiffs Jill Reardon and Judith Brachman (“Plaintiffs”) hereby give notice that it appeals to the Court of Appeals, Tenth Appellate District of Franklin County, Ohio, from the Franklin County Common Pleas Court’s denial of Plaintiffs’ Motion for Temporary Restraining and Preliminary Injunction (“Motion”). The Court’s decision is immediately appealable pursuant to Ohio Revised Code § 2505.02 (B)(1) and (4). The Court held a hearing on the Motion, commencing at approximately 6:30 p.m. on March 16, 2020. The undersigned was present at the hearing and during the Court’s decision denying the Motion, which was made orally from the bench. As of the time of filing this notice, the Court had not yet issued a written Order and/or entered a docket entry reflecting the Court’s oral ruling. However given the exigencies of the issues and the timeliness of the relief sought, Plaintiffs give immediate notice of the appeal.
