Oral argument in this matter will be held via WebEx videoconference on the date and time noted above.



Designated counsel will receive the conference link in advance of the scheduled argument. Only designated counsel presenting the oral argument will have access to the WebEx session. The designated arguing attorney may not share his or her WebEx conference link with anyone else.

The designated arguing attorney will be required to participate in a mandatory WebEx test session on the date and time noted above. **Using the enclosed response form, the designated attorney must provide the Court with an email address that the Court will use to send conference links to join the WebEx test and oral argument sessions. This form must be returned by email to Ramona.Wells@pacourts.us no later than 9:00 a.m., Tuesday, November 17, 2020.**
