Plaintiffs Mi Familia Vota, Arizona Coalition for Change, Living United for Change in Arizona, and League of Conservation Voters, Inc. d/b/a Chispa AZ (jointly, "Plaintiffs"), Defendant Arizona Attorney General, and nominal Defendant Arizona Secretary of State herein provide an update on the status of negotiations concerning resolution of this litigation short of trial.

On June 2, 2025, counsel for Plaintiffs and the Arizona Attorney General and Arizona Secretary of State reached an agreement in principle for resolution of the litigation, conditioned on the approval of Arizona's Voter Registration Advisory Committee ("VRAC"). The VRAC is composed of the nominal defendant county recorders in this action.

Under the terms of the proposed agreement, the VRAC would adopt guidance about best practices for implementation of SB 1485 and Plaintiffs would voluntarily dismiss their suit. Counsel for Defendant Arizona Attorney General and nominal Defendant Arizona Secretary of State sent the proposal to counsel for the county recorders on June 4, 2025, and the VRAC will meet on June 25, 2025, to consider the proposal.

Plaintiffs, the Arizona Attorney General, and the Arizona Secretary of State support the proposal, and the Arizona Attorney General and Arizona Secretary of State intend to voice support for the proposal during the June 25 meeting. Intervenor-Defendants Republican National Committee and Republican Senatorial Committee do not object to the proposed settlement agreement between the Plaintiffs and the named Defendants. One or more parties will update the Court after the June 25 meeting.
