**INTERVENORS' MOTION FOR SUMMARY JUDGMENT**

The Republican National Committee and the Ohio Republican Party (the "Intervenors") support and seek to uphold free and fair elections on behalf of all Ohioans. Intervenors therefore respectfully move the Court to uphold the Ohio General Assembly's duly enacted laws governing Ohio's elections and to enter summary judgment against Plaintiffs. Intervenors submit the accompanying memorandum in support demonstrating that summary judgment is warranted because the challenged provisions are lawful. R.C. § 3599.21(A)(9) and R.C. § 3509.05(C)(1) do not violate 42 U.S.C. § 12132, 29 U.S.C. § 794, 42 U.S.C. § 1983, 52 U.S.C. § 10508, or the Fifth or Fourteenth Amendments to the United States Constitution. Accordingly, Intervenors respectfully request that the Court grant this motion and enter judgment in their favor.
