**JOINT STATUS UPDATE
AND MOTION TO CON-
TINUE HEARING**

1 The parties jointly file this status update and request for a continuance of the
2 hearing currently scheduled for November 3, 2025.

3 1. Following the Ninth Circuit’s *en banc* rehearing order in *Arizona Alliance for*
4 *Retired Americans v. Mayes*, 117 F.4th 1165 (9th Cir. 2024), this Court held a status con-
5 ference on June 26, 2025, to determine how the rehearing order would affect this case.

6 2. At the hearing, the Court “enter[ed] a stay pending a decision in the Ninth
7 Circuit’s decision in *Arizona Alliance for Retired Americans v. Mayes* case.” ECF No. 167.
8 The Court also “denie[d] without prejudice” the pending motions to dismiss and motion
9 for leave to supplement authorities. *Id.* The Court scheduled a follow-up status confer-
10 ence for November 3, 2025, at 10:00 AM. *Id.*

11 3. The Ninth Circuit *en banc* panel heard oral argument in *Arizona Alliance for*
12 *Retired Americans* on June 26, 2025. The *en banc* panel has not yet issued a decision.

13 4. The parties to this case agree that current circumstances do not warrant
14 lifting the stay at this time.

15 5. Accordingly, the parties jointly request that the Court continue the status
16 conference scheduled for November 3, 2025.

17 6. If the status conference is continued, the Plaintiffs commit to filing a no-
18 tice and proposed briefing schedule when the Ninth Circuit issues an opinion in *Arizona*
19 *Alliance for Retired Americans*, No. 22-16490.
